Awareness Raising and Information Campaign in India

Acting together to promote research and innovation cooperation with India

10-28 September 2012

The European Union and its Member States are organising together another series of information seminars throughout India to raise awareness among Indian research stakeholders about the opportunities that they can offer for research and innovation cooperation, including mobility schemes for Indian students and researchers and partner search tools. This follows from the very successful campaign in 2011.

This campaign is also very timely considering the EU-India Joint Declaration on Research and Innovation Cooperation signed at the last EU-India Summit in New Delhi in February 2012 towards building an Indo-European Research and Innovation Partnership with (i) larger scale, scope and impact, (ii) focus on common societal challenges, and (iii) enhanced synergies between India, the EU and its Member States. Shared vision & pathways for the Partnership were highlighted at the meeting that the EU Commissioner and Ministers responsible for research and innovation in the EU Member States had with the Indian Minister for Science and Technology in Brussels in May 2012.

The Speakers:

53 European S&T counsellors and representatives of research organisations from Belgium, Czech Republic, Estonia, Finland, France, Germany, Italy, Lithuania, the Netherlands, Poland, Spain, Sweden, the United Kingdom, the

European Research Council, Euraxess Links India, the European Business and Technology Centre as well as from the Delegation of the European Union, will make some 155 presentations in 31 key research and innovation hot spots in India over a three-week period. In addition, five thematic sessions will also be organised and focus on biotechnology, industrial research, sustainable transport, ICT and health. Indian participants in cooperation programmes with Europe will also present their experience and lessons learnt.

Content of seminars:

In each of the cities the European Union's 7th Research Framework Programme will be presented. In addition, one or more of the EU Member States research and innovation cooperation programmes and opportunities may be presented. A memory stick provided to all the participants will provide the presentations made in each city and additional information.
