### **National Women Bioscientist Awards: 2002**

The Department of Biotechnology (DBT) invites nominations of women scientists who are currently working in the areas of Biology and Biotechnology and have made outstanding contributions in research, product and technology development. The nominations (15 copies) neatly typed on plain paper in the prescribed proforma complete with enclosures, two latest photographs with negative, brief (as per proforma) should be sent to the Director (Attn: Dr. Suman Govil), Department of Biotechnology, Block 2 (6–8th Floor), CGO Complex, Lodi Road, New Delhi 110 003 so as to reach on or before 15 November 2002. A copy may also be sent by e-mail to suman@dbt.nic.in.

The details of the scheme are as under.

1. Nature of the award: Three awards are given every year. There are two categories of awards.

#### Senior Women Bioscientist Award

One; for a senior women biologist for life-time contributions, who has done excellent research and has applied the results for the benefit of students and society. The award would carry Rs 1.00 lakh along with the citation and a gold medal.

#### Young Women Bioscientist Awards

Two; the awards would carry Rs 50,000 each with a citation and a gold medal for young women scientist below the age of 45 years for pursuing a brilliant research career in biology. Contributions made in the last 5 years would be the main consideration.

- 2. Eligibility: The women scientist should be a citizen of India and actively involved in research and teaching activities in biology and biotechnology in the country. For the senior category, there is no age limit. For the two young women bioscientist award, the candidate should be below 45 years of age as on December in the preceding year.
- 3. Nominations: Women scientist working in the area of biology/biotechnology can be nominated by members of the SAC-DBT, SAC(O), DBT, Vice-Chancellors of Universities/Deemed Universities, Chairman, UGC, DG, CSIR, ICAR, ICMR, DRDO, Directors of National Research Laboratories, etc. Presidents of approved scientific societies and academies of All India Nature, Secretaries of S&T Department such as DST, DBT, DSIR, DOD, MNES, MOEF, Atomic Energy, Space, Commerce, Industry, Ministry of Health & Family Welfare, Human Resource Development. Member (Science) Planning Commission may also nominate women scientist for the award. Nominations will have to be sent in the prescribed proforma. Nomination from individuals sponsoring their own names will not be considered.

- **4. Mode of selection:** The selection of candidates for the award will be made on the basis of recommendations of an expert committee constituted specifically for the purpose by the Department of Biotechnology. For the senior category, contribution made by the scientists during her entire career will be considered. For the young category, contributions made during the last 5 years will be the major consideration. Only the applications complete in all respect as per proforma and duly nominated will be considered. The decision of selection committee will be final and only the selected candidates will be informed.
- **5. Presentation of the award:** The award will be given to the selected women scientists at a formal function organised by the DBT on International Women's Day.
- **6. Payment of TA/DA:** TA/DA to the awardees for attending the award function will be paid by DBT as per Govt. of India rules.
